Preamble:

The Admission cell was set up in 04/07/2019 for the admission process of 1st MBBS 2019, second batch of AIIMS Mangalagiri under the supervision of Director, Deputy Director (Administration), Dean and Associate Dean (Academic & Exams). Dr. Desai Vidya Sripad, Associate Dean (Academic & Exams) was nominated as Nodal officer for counseling and admission process.

Responsibilities:

- 1) Admitting and registering under graduate medical students according to the institutional norms, rules and regulations of AIIMS New Delhi MBBS 2019.
- 2) Preparing a file for every student, this includes all his/her documents and record during presence and archiving afterwards in coordination with Administration.
- 3) Screening, Checking and auditing files of admitted students & keeping record for the same.
- 4) Preparing all necessary arrangements for registration of students and under graduate course, and monitoring academic load for students in accordance with the instructions.
- 5) Following up on matters related to transfer students from other institutes vice versa

- 6) Availability 24*7 for the necessary information/clarifications regarding Counselling/Admission process
- 7) Timely Uploading /convey the information /Necessary documents on the institute website for counselling admin process
- 8) Updating all the necessary information for every student in the electronic system and record in hard copy.
- 9) Timely Preparing statistics (for filled/vacant seats) and reports needed for admission process.
- 10) Issuance of Acknowledgement receipt to every student for submitting documents /DD at AIIMS Mangalagiri.
- 11) Updating the student fee (Academic & Hostel) in the Institute Account and coordination with hostel warden and Account section.
- 12) Coordination with Medical Superintendent for smooth conduct of Medical examination for all the students
- 13) Updating final selection list of students in the institute website with consent of AIIMS Mangalagiri Competent authority.

Conduction of entrance examination and Result declaration for AIIMS MBBS 2019

In AIIMS Mangalagiri for Academic year 2019-20 MBBS course, 50 Indian students (26 General Category, 07 Scheduled Caste, 3 Scheduled Tribe and 14 Other Backward Classes) are admitted. These admissions were made based on merit through an All-India Entrance Examination.

The results of AIIMS MBBS 2019 entrance examination held for 1,150 seats across the country were declared on June 12th 2019. Total 3, 38,457 candidates comprising 1, 57,488 males, 1, 80,934 females and 35 third gender candidates appeared for the examination, Out of them, 11,380 have qualified - 7,352 males, 4,027 females and one third gender candidate. The examination was held on May 25th and 26th 2019. The examination was conducted online in four shifts for over two days. It was organized in 339 centers in 151 cities spread over 29 states and three Union Territories.

Counselling Process for AIIMS MBBS 2019 at AIIMS Mangalagiri:

Three rounds of counselling from 1st July 2019 to 14/08/2018 at AIIMS Mangalagiri, and open round counselling/seat allocation on 26th and 27th of August 2019 was held at AIIMS New Delhi.

Results of 1st round online seat allocation/ Counselling of mock round of AIIMS –MBBS-2019 was announced on 29th June 2019. A total of 41 candidates who have been allotted a seat in the 1stRound of Online Seat Allocation/Counselling are reported for depositing original certificates OR a Demand Draft (DD) of Rs. 1 Lakh only (Rupees One Lakh only) in the name of the allotted AIIMS along with photocopies of certificates and chosen desired options during 1st round of seat allocation /Counselling process held on 01.07.2019, 5.00 p.m. (Monday) to 04.7.2019, 5.00 p.m. (Thursday) at AIIMS Mangalagiri under the super vision of Nodal officer.

A result of 2nd round of seat allocation /Counselling of mock round of AIIMS –MBBS-2019 was announced on 22nd July 2019. A total of 24 candidates who have been allotted a seat in the 2nd Round of Online Seat Allocation/Counselling are reported for depositing original certificates OR a Demand Draft (DD) of Rs. 1 Lakh only (Rupees One Lakh only) in the name of the allotted AIIMS along with photocopies of certificates and chosen desired options during 2nd round of seat allocation /Counselling process held on 22.07.2019, 5.00 p.m. (Monday) to 26.7.2019, 5.00 p.m. (Thursday) at AIIMS Mangalagiri under the super vision of Nodal officer.

A result of 3rd round of seat allocation /Counselling of mock round of AIIMS –MBBS-2019 was announced on 09th August 2019. A total of 19 candidates who have been allotted a seat in the 3rd Round of Online Seat Allocation/Counselling are reported for depositing original certificates OR a Demand Draft (DD) of Rs. 1 Lakh only (Rupees One Lakh only) in the name of the allotted AIIMS along with photocopies of certificates and chosen desired options during 3rd round of seat allocation /Counselling process held on 10.08.2019, 5.00 p.m. (Monday) to 14.8.2019, 5.00 p.m. (Thursday) at AIIMS Mangalagiri under the super vision of Nodal officer.

Open round counselling/seat allocation was held on 26th and 27th August 2019 at AIIMS New Delhi. Dr.Desai Vidya Sripad (Nodal officer for counselling and Admissions) and Mr.Saidaiah Ikkurthi (Counselling committee member) attended open round counselling for allotment of vacant seats in AIIMS Mangalagiri and also coordinated with AIIMS New Delhi for smooth conduct of Counselling. Total of 27 students out of 50 were allotted to AIIMS Mangalagiri by the end of open round counselling and the remaining 23 students were allotted from above three rounds of counselling.

Admission process for AIIMS Mangalagiri:

After the completion of the counselling process, candidates reported at AIIMS Mangalagiri on 3rd September 2019 to complete Institutional formalities of admission.

The admission payment (for Academic 1628/- and hostel 4228/-) onetime payment for ^{51/2} years was received from candidates by competent authority, deposited same in the Institutional account and issued receipts for the same to every candidate on the same day. It will be compulsory to pay the admission fee to complete the AIIMS Mangalagiri admission process.

In case of Scheduled Caste/Scheduled Tribe candidates, should have secured 60% marks or above in aggregate in the subjects of English, Physics, Chemistry (organic and inorganic) and Biology (Botany and Zoology).
- Migration Certificate from the University/ Institute last attended
- Caste Certificate in the prescribed form as appended in the Prospectus showing that
 candidates belong to SC/ST/OBC/OPH category (applicable only if you have claimed in the
 application that belongs to an SC/ST/OBC/OPH category). (*OBC certificate should be valid for
 central government jobs/Central government institutions only, otherwise claim for OBC
 reservation will not be considered).
- Current passport size photograph (front pose) 6 copies.
- One set of self-attested copies of all the certificates.
