- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid data sheet (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.
- 4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 5. Past Experience of Similar Services: The Bidder must have successfully executed / completed at least one single order of 80 % of the Estimated Bid Value or 2 orders each of 50 % of the Estimated Bid Value or 3 orders each of 40 % of the Estimated Bid Value for similar service(s) in last three years to any Central / State Govt Organization / PSU / Public Listed Company. Copies of contracts / work orders and documentary evidence of successful execution / completion in support of Past Experience of Similar Services along with names, address and contact details of clients shall be uploaded with the bid for verification by the Buyer.
- 6. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

1. <u>Pre-qualification Criteria:</u> Intending Bidder(s), fulfilling eligibility criteria as mentioned below may submit their bid provided they have definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority of having satisfactorily completed similar works in last 05 years. The similar workshall mean:

Supply, Installation, Testing and Commissioning of at least 750 TR installed capacity of Water CooledCentral AC Plant with at least 1 No. Chiller of minimum capacity of 400TR along with chilled water pipelines, chilled water pumps, condenser pumps, cooling towers, Chiller plant manager, AHUs/CSUs/FCUSandassociatedcontrols &installations.

Copy of work order(s) & respective satisfactory completion certificate(s) must be furnished by the bidder inTechnicalBidinsupport ofeligibility.

- c. The Bidder should have up to date registration with Employee Provident Fund(EPF) Commissioner and Employee State Insurance(ESI) Corporation.
- d. The bidder should have positive net worth in last 03 (Three)Yearsendingi.e., by 31st March2022, duly certified by Charted Accountant.
- e. The experience of similar work should be from Central Govt., State Govt., PSU, Autonomous Body, Govt.Hospitals.
- f. Thebidder must be an Original Equipment Manufacturer (OEM) of Chiller and associated low side equipment ofHVAC system or an Original Equipment Supplier (OES) of Carrier make Centrifugal Chiller i.e., who has supplied, installed and maintained the same AC plant and associated machineries/equipment or Authorized Service Provider of M/s Carrier (OEM). Valid Documentary evidence of Manufacturer/Original Equipment Supplier/Authorized Service Provider must be submitted by the bidder.
- g. The bid document consisting of plans, specifications, the schedule of quantities of the varioustype of items to be executed and the set of terms & conditions of the contract

to be complied with and other necessary documents.

- h. Conditional Bids shall not be considered and will be outrightly rejected at the very first instance.
- Bidder should submit a letter on their letter head stating they shall comply all terms and conditions mentioned in bid document
- Bidder shall be paid separately for the spare parts which are excluded in the scope of work(i.e. specific exclusions) on actual basis. All other spares Will be part of CAMC and included in contract.

2. **SPECIFIC EXCLUSIONS:**

The following works are not included under the contractor's scope of work of Comprehensive Annual Maintenance Contract:

- Every effort will be made by the Contractor in servicing condenser and chilled water pumps and if they go beyond repair due to ageing, they would be replaced by the AIIMS. However, the labour cost for replacement will be borne by the firm, under maintenance contract.
- Works related to AHU sheet metal panels, base tray and thermal insulation materials will be provided by successful bidder at rate quoted for rate contract items in this tender and the work to be carried out by the Firm under AMC.
- Works related to sheet metal panels, water piping, cooling tower uprights, fills, cooling tower PVC panels – materials will be supplied by successful bidder at rate quoted for rate contract items in this tender and work will be done by the firm under AMC.
- New works of ducting, duct lining, false ceiling and masonry / steel structure works
- Replacement of valves in the cooling tower area, but effort should be made for servicing. The valves required for replacement will be supplied by successful bidder at rate quoted for rate contract items in this tender and the work will be done by the firm under AMC.
- Replacement of HEPA filters, Pre and fine filters. If replacement is necessary, the material will be supplied by successful bidder at rate quoted for rate contract items in this tender and the work will be done by the firm under CAMC.
- Installation/re-installation of Centralized Air conditioning system.

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य</u> नियम और शर्तें, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्तें is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
