On behalf of The Director, AIIMS Mangalagiri invites Quotations with price bid and other documents from eligible Manufacturers/ Firms/ Companies/ Authorized Agents/ Distributors/ Dealers/ Supplier Agencies for "Supply of Labour Delivery Beds " for OBG Department, AIIMS Mangalagiri, as per specified terms and conditions.

1. Schedule of Requirement:-

2. <u>Technical Specifications for Labor Delivery Beds.</u> <u>Delivery Bed should have the following essential Specifications:</u>

a. Overall size 2100- 2400 mm Length when extended, 900mm-1100mm Width (with and without side rails up), 440 mm to 900mm Height (without mattress).

b. It should have control devise for making height and adjustment (Remote control).

- c. Bed should have three section high pressure laminated top. It should have detachable laminated top for middle section and leg section for ease of cleaning. Leg section should be telescoped under backrest for lithotomy position.
- d. Frame should be made of mild steel which should be pre treated and power coated.
- e. Bed shall have swing down type side railings; railings shall be made from non-rusting polymer moulded material.
- f. It should have three sectional mattress and seat section should have large perineal cut.
- g. Mattress should be made of high resilience high quality P.U foam with stain resistant cover and zip.
- h. Should have a pair of bearing down patient hand grips with PVC covers and with location adjustability for patient convenience.
- i. All positions should be operated by electromechanical adjustment through a hand set; battery backup with inbuilt battery charger should be provided. The hand set should have indications for power on and the battery charge.
- j. It should have polymer moulded easily detachable head and foot side panels. It should have four corner rubber buffers.
- k. Bed should be mounted on 12cm -15cm non rusting castor wheels with locking mechanism. Castor should be made from high grade non floor staining synthetic material. Wheel center should have precision ball bearing to run smoothly.
- 1. Should have infusion rods which have adjustable heights, quick release and attaches to all corners of bed.

- m. Should have a pair of upholstery aluminum crutches mounted on SS tubes.
- n. Should have sliding waste collection bowl at perineal part of table.
- o. It should be able to give trendelenburg, reverse trendelburg and 60-70 degree sitting position both electronically (remote operated) and mechanically.
- p. It should have adjustable foot supports for nursing staff.
 - i. All consumables required for installation and standardization of system to be given free of cost.
 - ii. Shall meet/comply with General Requirements of Safety for Electromagnetic Compatibility.
- The unit shall be capable of being stored continuously in ambient temperature of 10-40deg C and relative humidity of 15-90%
- iv. The unit shall be capable of being stored continuously in temperature of 0-50deg C and relative humidity of 15-90%.
- v. Power input to be 220-240VAC, 50Hz fitted with Indian plug.
- vi. UPS of suitable rating with voltage regulation and spike protection for 60 minutes back up.

3. Technical Bid Documents:-

All the documents mentioned below are mandatory and are to be placed in the Technical Bid Envelope .They should be duly signed and pages numbered.

a) Undertaking for acceptance of Terms & Conditions of AIIMS Mangalagiri against the NIQ should be printed on the Official Letter Head of participating Bidder Company, duly signed and Stamped and accompanied with Technical Bid Document as per Format given at Annexure-II.

b) Copy of Certificates/Standards for confirming the Quality of Supplied product: The quoted Item/Items should have applicable quality mark such as *ISI/BIS/ISO* 9002 for Quality assurance in Production and its utmost safety compliance for use in patient care should be mentioned and the copy of such applicable certification must be enclosed with the Technical Bid.

c) Purchase Order / RC Copy from INI such as AIIMS Delhi, PGI Chandigarh, JIPMER, SGPGIMS, RML, State Government and Prominent Private Organizations, for the rates reasonability for the earlier supplied items, in the last financial years, if any.

d) **Authorization Certificate:** The name and address with the complete email ID and the validity period of the Authorization Certificate, if any, needs to be mentioned.

e) Fall clause: If at any time during the period of contract, the price of this NIQ items is reduced or brought down by any law or Act of the Central or State Government, the supplier shall be bound to inform the Purchasing Authority immediately about such reduction in the contracted prices. In case the supplier fails to notify or fails to agree for such reduction of rates, the Purchasing Authority will have the right to revise the rates on lower side. If there is a price increase for any product after quoting the rates, the bidders have to supply the item as per the quoted rates.

f) Delivery period: Delivery period of the items shall be **15 days** from the issue of supply order. The period of delivery has to be strictly followed by the Supplier Agency as communicated through Purchase/Supply Order.

g) **Penalty:** Penalty @ **0.50% per week** will levied for late delivery on supply order value of the item and will be deducted from the payment Bill. The maximum penalty will be **10 %** of total value against any of Purchase/Supply Order total value.

h) **Warranty Period**: Should be clearly mentioned in the quotation as per the OEM or company Norms.

4. Financial Bid Documents:-

a) **Price Basics:** Unit base price should be inclusive of GST and all applicable expenses up to F.O.R (Freight on road) at AIIMS Mangalagiri.

b) Price Validity: The quoted prices should remain valid for a period of **180 days** from date opening of NIQ.

c) **Price Quotation Format:** Price should be quoted in the "Financial Bid" **format given at Annexure-I strictly** by the vendor.
