On behalf of The Director, AIIMS Mangalagiri Quotations are invited with price bid and other documents from eligible Manufacturers/ Firms/ Companies/ Authorized Agents/ Distributors/ Dealers/ Supplier Agencies for “Supply of Non-Consumables” at AIIMS Mangalagiri, as per specified terms and conditions.

II A. Specifications of Hand Grip Dynamometer:

- Dial type manual handgrip dynamometer.
- Dial scale 0-60kg
- Two pointer system- one pointer for target setting and another pointer for measuring Handgrip.
- All metallic points should be treated for anti-corrosion
- Internal spring system must be calibrated against standard weights & measures.
- Facility for connecting manometer.

B. Specifications of Marey's Tambour:

- This device should convert changes in air pressure into movements of a stylus that scribes a kymograph.
- Diameter 22mm or 28mm (Approx).
- Stainless Steel capillary lever and "hollow stem.
- Sliding adjustment to writing point should have tie-on Diaphragm.

C. Specifications of Kymograph E-8 Electrical:

- Speeds from 0.12 mm/sec to 640 mm/sec
- 8 steps in speed gear- hand gear
- Oil lapped gear system
- Electric motor Instantaneous Start and stop Clutch
- Cylinder-6 inch diameter
- Stainless Steel Spindle screw lift

- g. Double electric Contact arms Clamped on the main spindle and a stout double-contact block fitted on top of the base.
- h. Special Heavy Duty motor
- i. Jerk Free Running
- j. Voltage-220V-240V

D. Specifications of Stethograph:

- a. Corrugated high-quality rubber/silicon tube.
- b. Should be 60 cm long unstretched and 2 cm in diameter.
- c. One end is closed with air tight metallic stopper and other end opens into a Nozzle through an air tight metallic adapter.
- d. Suitable flexible high-grade silicon tube of length at least two meters.

E. Specifications of Compass Aesthesiometer:

- a. Made of high-quality brass.
- b. High precision adjustment screw for changing the distance between the leg tips (at least 1mm for half a circle screw turn).

F. Specifications of Von Frey Aesthesiometer-Horse Hair Type:

- a. Must contain standard recommended horse tail hair type material.
- b. The horse hair must be contained in a graduated tube holder (0-30mm).
- c. The length of the protruding part of the hair must be adjusted by screwing method.
- d. The length of protruding part of the hair must be read directly on a scale.
- e. Must contain a protective screw cap

G. Specifications of Slim guide-skin fold Caliper:

- a. To Measure Body fat.
- b. Calibrated jaw width can measure up to 80mm, suitable for larger non-athletic populations where this may be required.
- c. Can be read to the nearest 0.5 mm.
- d. Easy to use pistol grip trigger.
- e. Dual springs for consistent measurements.
- f. Graduation from 0 to 80mm.
- g. Made of durable ABS Plastic.
- h. Analog method of Measurement.
- i. Acceptable make Flovein, apex, mitutoyo.

III. Technical Bid Documents

All the documents mentioned below are mandatory and are to be placed in the Technical Bid Envelope. They should be duly signed and pages numbered.

a) The firm should provide an undertaking for acceptance of Terms & Conditions of AIIMS Mangalagiri against the NIQ. It should be printed on the Letter Head of participating Bidder Company, duly signed and accompanied with Technical Bid Document as per Format given at Annexure-II.

b) Copy of Certificates/Standards for confirming the Quality of Supplied product: The quoted Item/Items should have applicable quality mark such as *ISI/BIS/ISO 9002* for Quality assurance in Production and its utmost safety compliance for use in patient care should be mentioned and the copy of such applicable certification must be enclosed with the Technical Bid.

c) Purchase Order / RC Copy from INI such as AIIMS Delhi, PGI Chandigarh, JIPMER, SGPGIMS, RML, State Government and Prominent Private Organizations, for the rate reasonability for the earlier supplied items, in the last financial years, if any.

d) **Delivery period:** Delivery period of the items shall be **21 days** from the issue of supply order. The period of delivery as communicated through purchase/Supply order has to be strictly followed by the Supplier.

e) **Penalty:** Penalty @ **0.50% per week** will levied for late delivery on supply order value of the item and will be deducted from the payment Bill. The maximum penalty will be **10 %** of total value against any of Purchase/Supply Order total value.

f) **Warranty Period:** Should be clearly mentioned in the quotation as per the OEM or company norms.

IV. Financial Bid Documents:-

a) **Price Basics:** Unit base price should be inclusive of GST and all applicable expenses up to F.O.R (Freight on road) at AIIMS Mangalagiri.

b) **Price Validity:** The quoted prices should remain valid for a period of **180 days** from date of opening of NIQ.

c) **Price Quotation Format:** Price should be quoted in the “Financial Bid” format given at **Annexure-I strictly** by the vendor and cannot exceed Rs.2.5 Lakhs.

V. The outer envelope should be super scripted as “**Supply of Non-Consumables**” at **AIIMS Mangalagiri**, and provided in sealed condition for the supply of item/items detailed in the Schedule of Requirement. All quotations should be type written or written with indelible ink, duly signed, stamped and pages numbered. Over written and erased entries will not be considered and treated as deleted entries.
