On behalf of The Director, AIIMS Mangalagiri Quotations are invited with price bid and other documents from eligible Manufacturers/ Firms/ Companies/ Authorized Agents/ Distributors/ Dealers/ Supplier Agencies for "Supply of Platelet Rich Plasma Machine" at AIIMS Mangalagiri, as per specified terms and conditions.

2. Specifications of Platelet Rich Plasma Machine

- a. Platelet Rich Plasma Machine to produce highly concentrated platelet rich plasma, with minimum 5-6 time highly concentrated PRP.
- b. To provide table top centrifuge machine.
- c. Maximum speed of the centrifuge machine to be around 4000 RPM.
- d. It has maximum force around 2900 g, maximum capacity to be around 200 ml (Minimum 4 tubes capacity).
- e. Microprocessor Controls on all run parameters (RPM/RCF, acceleration, deceleration, time and temperature) for consistent high platelet's yield.
- f. Centrifuge machine to show numeric display, timer etc.: LCD display to select parameter, feather touch keypads.
- g. Provide with program to pre-cool / run at recommended temperature for blood processing-to avoid hemolysis. There should be adjustable centrifugation speed and time.
- h. Power supply of the centrifuge machine should be available.
- i. Presence of safety features Door interlock, Imbalance cut off, overload protection.
- j. Hygienic: Easy to clean stainless chamber.
- k. Machine must be ISO approved.
- 1. 5 years Comprehensive Maintenance Contract including spares replacement and 50 PRP Kits may be quoted separately Kits volume will be minimum 25ml.

3. Technical Bid Documents

All the documents mentioned below are mandatory and are to be placed in the Technical Bid Envelope. They should be duly signed and pages numbered.

- a) The firm should provide an undertaking for acceptance of Terms & Conditions of AIIMS Mangalagiri against the NIQ. It should be printed on the Letter Head of participating Bidder Company, duly signed and accompanied with Technical Bid Document as per Format given at Annexure-II.
- b) Copy of Certificates/Standards for confirming the Quality of Supplied product: The quoted Item/Items should have applicable quality mark such as *ISI/BIS/ISO* 9002 for Quality assurance in Production and its utmost safety compliance for use in patient care should be mentioned and the copy of such applicable certification must be enclosed with the Technical Bid.
- c) Purchase Order / RC Copy from INI such as AIIMS Delhi, PGI Chandigarh, JIPMER, SGPGIMS, RML, State Government and Prominent Private Organizations, for the rate reasonability for the earlier supplied items, in the last financial years, if any.
- **d) Delivery period:** Delivery period of the items shall be **21 days** from the issue of supply order. The period of delivery as communicated through purchase/Supply order has to be strictly followed by the Supplier.
- e) Penalty: Penalty @ 0.50% per week will levied for late delivery on supply order value of the item and will be deducted from the payment Bill. The maximum penalty will be 10 % of total value against any of Purchase/Supply Order total value.
- f) Warranty Period: Should be clearly mentioned in the quotation as per the OEM or company norms.
- 4. Financial Bid Documents:-
- a) **Price Basics:** Unit base price should be inclusive of GST and all applicable expenses up to F.O.R (Freight on road) at AIIMS Mangalagiri.
- **b) Price Validity:** The quoted prices should remain valid for a period of **180 days** from date of opening of NIO.
- c) Price Quotation Format: Price should be quoted in the "Financial Bid" format given at Annexure-I strictly by the vendor and cannot exceed Rs.2.5 Lakhs.
- **5**. The outer envelope should be super scripted as "Supply of Platelet Rich Plasma Machine" at AIIMS Mangalagiri, and provided in sealed condition for the supply of item/items detailed in the Schedule of Requirement. All quotations should be type written or written with indelible ink, duly signed, stamped and pages numbered. Over written and erased entries will not be considered and treated as deleted entries.
