- c) Purchase Order / RC Copy from INI such as AIIMS Delhi, PGI Chandigarh, JIPMER, SGPGIMS, RML, State Government and Prominent Private Organizations, for the rates reasonability for the earlier supplied same consumables, in the last three Financial Years/ if available.

- **d) Authorization Certificate:** Please mention the name and address with the complete email id and the validity period of the Authorization Certificate may be mentioned.
- **e)** Fall clause: If at any time during the period of contract, the price of this NIQ items is reduced or brought down by any law or Act of the Central or State government, the supplier shall be bound to inform Purchasing Authority immediately about such reduction in the contracted prices. In case the supplier fails to notify or fails to agree for such reduction of rates, the Purchasing Authority will revise the rates on lower side.
