Computer Based Test (CBT) for the post of Various Non-Faculty Posts (Group B & Group C) was conducted from 08.12.2023 to 10.12.2023 vide ref. above. 'Objection Tracker with answer key' for the CBT was uploaded on the website of AIIMS, Mangalagiri on 13.12.2023 for receiving any appeals/objections and it was active up to 11:59 PM on 14.12.2023.
