3) Performance Security deposit:

a) The firm shall furnish a Performance Security deposit amount of **₹ 4,50,000/-** (Rupees Four Lakhs Fifty Thousand only) in the form of Insurance security bonds, Account Payee, Demand Draft, Fixed Deposit Receipt, Bankers Cheque or Bank Guarantee from any commercial bank, may be drawn in the favor of “AIIMS Mangalagiri – Receipts” or deposit /transfer to the following Bank Account details (Account no: 38321557910, IFSC- SBIN0061485, A/c Name- AIIMS Mangalagiri – Receipts) or payment online in an acceptable form safeguarding the purchaser’s interest in all respects through any Scheduled Bank with a clause to enforce the same on their

local branch at Mangalagiri within 30 days from the date of issue of Letter of Award (LOA).

b) Validity of the performance security deposit shall be for a period of 60 days beyond contractual obligation of 24 months.

c) The performance security deposit should be submitted in the *Procurement cell, 2nd floor, Admin & Library building, AIIMS Mangalagiri, Guntur District, Andhra Pradesh-522503* within 15 days from the date of issue of Letter of Award.

d) Extension of time for submission of PSD beyond 30 days from the date of issue of LOA may be given by the competent authority to sign the contract agreement however a penal interest of 15% per annum shall be charged for the delay beyond 30 days after the date of issue of LOA.

e) In case of failure to submit the requisite PSD even after 60 days from the date of issue of LOA the contract shall be terminated. The firm shall be debarred from participating in re-tender (if any) for that item.
