## **II . General Specifications of Basic Cranial Instrument Set:**

1	All the instruments should be made of corrosion-free surgical grade stainless steel SS 400 grade or better and the bidder should submit an original OEM certificate for the same
2	All the firms are required to submit their catalog along with tender/quotation clearly marking the quoted item and no. with a highlighter.
3	It should be of high quality and precision.
4	It should be lightweight, strong, and durable.
5	It should be non-magnetic.
6	All instruments should be autoclavable at 134 degrees Celsius
7	The TC inlay should be welded to the instrument and not pasted.
8	All instruments should be supplied from a single manufacturer (80% of the instruments should be from the same manufacturer). Undertaking from the principal manufacturer should be submitted for not manufacturing balance instruments. Rest 20% items should also meet quality standards as asked in the tender Note: MAF is required only for the principal manufacturer
9	Manufacturers should meet the International Certification as per ISO 13485
10	Instruments are to be supplied in autoclavable instrument boxes with silicone padding for delicate instruments.
11	Tolerance of +/- 10% is acceptable in dimension for all instruments
12	A warranty period of not less than 1 year for all items. The defective items should be repaired and replaced as required in the warranty period
13	All the instruments should be European CE with 4 digits notified body no or US FDA or BIS approved

## **III. Technical Bid Documents**

**All the documents mentioned below are mandatory and are to be placed in the Technical Bid Envelope. They should be duly signed and pages numbered.**

**a) The firm should provide an undertaking for acceptance of Terms & Conditions of AIIMS Mangalagiri** against the NIQ. It should be printed on the Letter Head of participating Bidder Company, duly signed and accompanied with Technical Bid Document as per **Format given at Annexure-II.**

**b) Copy of Certificates/Standards for confirming the Quality of Supplied product:** The quoted Item/Items should have applicable quality mark such as **ISI/BIS/ISO 9002** for Quality assurance in Production and its utmost safety compliance for use in patient care should be mentioned and the copy of such applicable certification must be enclosed with the Technical Bid.

**c) Purchase Order / RC Copy from INI** such as AIIMS Delhi, PGI Chandigarh, JIPMER, SGPGIMS, RML, State Government and Prominent Private Organizations, for the rate reasonability for the earlier supplied items, in the last financial years, if any.

**d) Delivery period:** Delivery period of the items shall be **21 days** from the issue of supply order. The period of delivery as communicated through purchase/Supply order has to be strictly followed by the Supplier.

**e) Penalty:** Penalty @ **0.50% per week** will levied for late delivery on supply order value of the item and will be deducted from the payment Bill. The maximum penalty will be **10 %** of total value against any of Purchase/Supply Order total value.

**f) Warranty Period:** Should be clearly mentioned in the quotation as per the OEM or company norms.

#### **IV. Financial Bid Documents:-**

**a) Price Basics:** Unit base price should be inclusive of GST and all applicable expenses up to F.O.R (Freight on road) at AIIMS Mangalagiri.

**b) Price Validity:** The quoted prices should remain valid for a period of **180 days** from date of opening of NIQ.

**c) Price Quotation Format:** Price should be quoted in the “Financial Bid” **format given at Annexure-I strictly** by the vendor and cannot exceed Rs.2.5 Lakhs.

**V.** The outer envelope should be super scripted as “**Supply of BASIC CRANIAL INSTRUMENT SET**” at **AIIMS Mangalagiri, and address of the vendor**, provided in sealed condition for the supply of item/items detailed in the Schedule of Requirement. All quotations should be type written or written with indelible ink, duly signed, stamped and pages numbered. Over written and erased entries will not be considered and treated as deleted entries.
