The Terms of Reference of these committees will be as follows:

1. The Executive committee, with necessary assistance of Technical Committee, shall spearhead the establishment of "The Andhra Pradesh Centre of Excellence in Immunotherapy & Pharmacotherapeutics@AIIMS Mangalagiri" under the mentorship of Prof. T.S. Ravikumar, President AIIMS, Mangalagiri. This centre will facilitate Research, Training and Quality accreditation aspects for Immunotherapy & Pharmacotherapeutics for the researchers and clinicians across the state of Andhra Pradesh, and will exist for the benefit of community.
2. The Executive committee shall explore the feasibility to start with a Multicentric Phase II, Open Label, randomized controlled study for COVID19 patients and design a protocol at the earliest. The Executive committee will identify the infrastructure and HR resources with the active help of VC, NTR University and DME, Government of Andhra Pradesh; chart a framework to commence the plasma-therapy; draft a plan to utilize the infrastructure and Human Resources of AIIMS and Government of AP; draft proposals for approval accordingly and commence the Centre of Excellence at the earliest. In this regard, the Executive Committee shall seek administrative support from the Director, DD (A), FA, Dean and MS. The DD(A) will also liaise with the Commissioner (PRAP) and any other officers of Government of Andhra Pradesh and the Central Government.



3. The Committees shall identify the Gaps in the infrastructure and Human resources and synergize with the Outreach group of Nodal Officers of respective Medical Colleges to fulfil the required criteria.

4. Any other task ancillary to the commencement of Centre of Excellence.

The Committee members shall not be entitled for any remuneration in this regard.
