It is hereby notified for information of all concerned that published tender - bid against the tender ID No. 2024_AIMSM_796124_1 and tender Notice No. AIIMS-MG/BID/PMJAK, published on 17/02/2024 for the “**Notice Inviting Tender for Establishment of Pradhan Mantri Bhartiya Janaushadhi Kendra (PMBJAK) in AIIMS Mangalagiri, Andhra Pradesh**”.

The following changes are made in the terms and conditions of the tender document and the end date for the tender has been extended for a period of 10 days from the date of issue of this corrigendum.

1. Section: 2 instructions to bidders, 2.2 eligibility criteria, 2.2.1 the table under technical capacity has been replaced as under:

- a. The bidder who scores max marks out of 50 shall be offered to sign the tripartite agreement with AIIMS Mangalagiri & PMBI to establish Janaushadhi Kendra.
- b. In case more than one bidder obtains the same total score, the bidder scoring maximum marks on point number 1 will be selected.

- c. In case more than one bidder obtains the same total score and same score on the evaluation parameter number 1, then the Bidder running more number of Janaushadhi Kendra will be selected (Bidders to submit proof/ documents to substantiate number of Janaushadhi Kendras being run by them).
 - d. In case more than one bidder obtains the same total score, and same scores on evaluation parameter number 1 and have been running equal number of Janaushadhi Kendra then, the Bidder with greater number of years of experience will be selected.
 - e. In case more than one bidder matches all the above criteria then the bidder with higher turnover will be selected.
2. **2.2.2 Financial Capacity:** For demonstrating financial capacity, the Bidder shall fulfill the following minimum eligibility criteria: -
 - a. The Bidder shall have positive Net Worth at the close of the preceding financial year; and
 - b. The Bidder shall have minimum average Annual Turnover specified of 25 lakhs in similar services during past three years preceding the bid due date.
 3. Appendix 1A, ANNEX-V is replaced as appended to this Corrigendum.
 4. The other terms & conditions stipulated vide tender No. 2024_AIMSM_796124_1 dated 17.02.2024 shall remain same.
 5. The bids that have been received prior to this corrigendum shall not be entertained. Therefore bidders who have already submitted the bids are hereby requested to resubmit their bids again.
