2. All other terms and conditions contained in previous order dated 31.08.2024 shall stand modified / amended as under:

i. The promotion shall be provisional and if anything detected on a later date that makes him / her ineligible for the promotion and on that event, the promotion will be cancelled.

ii. He / she is directed to give his / her acceptance to nursing establishment through proper channel for assumption of charge to the post within 7 (seven) days from the date of issue of this order and report for duty failing which the offer of promotion made to him / her will be treated as cancelled / withdrawn. **However, the employees, who had already submitted their acceptance in response to previous order, need not submit his / her acceptance again.**

iii. In case, he / she refuse to join the new post on promotion within stipulated period, such act will be considered as refusal of promotion and promotion order to be treated as cancelled / withdrawn. Accordingly, as per DoPT instruction on the subject he / she will be debarred from promotion for a period of one year or till such time next vacancy arises, whichever is later.

iii. He /she is advised to exercise his / her option for fixation of his / her pay under FR-22(I) either from the date of his / her promotion to the post or from the date of drawl of his / her next increment in the present post within one month from the date of issue of this Order, provided he / she has not been granted Level-8 of pay matrix under ACP/MACP scheme.

iv. The above promotion is subject to the outcome of pending cases / judgments or orders, if any, passed by the Courts / Tribunals or any other clarification issued from the DoPT / MoHFW in this regard.

v. The above officials will be on probation for a period of two years from the date of joining to promotional post. During the period of probation, the officials will be required to put in satisfactory service, failing which their service will be liable to be reverted at any time without any notice or reason being assigned for the same.

vi. Other terms and conditions of their service will be the same as are applicable to other employees of the Institute.

vii. The seniority of Senior Nursing Officer (Group B) in Pay Level – 08 shall be decided later separately.
