

No. 01/2014, as the date of birth was wrongly filled in the application form, is now provisionally selected and recommended for appointment in compliance of Hon'ble CAT, Jaipur orders in O.A. No. 291/0664/2016, after dismissal of Writ Petition and Special Leave Petition filed, by this RRB, in High Court, Jaipur and Supreme Court respectively.
- \*\*\*21 ST vacancies cannot be filled up as suitable qualified candidates are not available under ST quota.
- Community breakup of the candidates now being empanelled is provisional and likely to be changed while giving replacement panels.
  - For example: a candidate empanelled now under OBC quota may be considered under UR quota in future while giving supplementary panel because of the fact that candidates above his merit selected under UR quota may not report for appointment and may become unfit in medical test etc and hence subject OBC candidate then will be considered under UR quota and accordingly released OBC vacancy will be filled by the available OBC merit candidate only but not as per UR merit.
