- If any candidate fails to attend the DV on the above date, his/her candidature will be cancelled and no further opportunity will be afforded.
- 6. It may be noted that merely calling a candidate for Document Verification does not entitle him/her in any way to an appointment in the Railways. The candidature of all the candidates is provisional and is liable to be cancelled at any stage of recruitment or thereafter, in case of any discrepancy, inconsistency or deficiency in the data furnished by them or any malpractice on their part at any stage of the recruitment process.
